## EXECUTIVE SUMMARY

---

The purpose of hazard mitigation is to reduce or eliminate long-term risk to people and property from hazards. Laclede County and participating jurisdictions and school/special districts developed this multi-jurisdictional local hazard mitigation plan update to reduce future losses from hazard events to Laclede County and its communities and school/special districts. The plan is an update of a plan that was approved on July 31, 2019. The plan and the update were prepared pursuant to the requirements of the Disaster Mitigation Act of 2000 to result in eligibility for the Federal Emergency Management Agency (FEMA) Hazard Mitigation Assistance Grant Programs.

The County Multi-Hazard Mitigation Plan is a multi-jurisdictional plan that covers the following jurisdictions that participated in the planning process:

- Unincorporated Laclede County
- City of Lebanon
- City of Richland
- Village of Phillipsburg
- Laclede County C-5 School District - Joel E. Barber
- Lebanon R-III School District
- Richland R-IV School District
- Gasconade C-4
- Laclede County R-I School District

Plato R-V School District, Stoutland R-II School District, Conway, and Stoutland were invited to participate in the planning process but did not meet all the established requirements for official

participation. When the future five-year update is developed for this plan, the jurisdictions will be invited again to participate. Plato R-V School District submitted a questionnaire but declined to submit action item, thus was determined not a participating jurisdiction.

Laclede County and the entities listed above developed a Multi-Jurisdictional Hazard Mitigation Plan that was approved by FEMA on July 31, 2019 (hereafter referred to as the 2019 Hazard Mitigation Plan). This current planning effort serves to update that previously approved plan.

The plan update process followed a methodology in accordance with FEMA guidance, which began with the formation of a Mitigation Planning Committee (MPC) comprised of representatives from Laclede County and participating jurisdictions. The MPC updated the risk assessment that identified and profiled hazards that pose a risk to Laclede County and analyzed jurisdictional vulnerability to these hazards. The MPC also examined the capabilities in place to mitigate the hazard damages, with emphasis on changes that have occurred since the previously approved plan was adopted. The MPC determined that the planning area is vulnerable to several hazards that are identified, profiled, and analyzed in this plan. Riverine and flash flooding, winter storms, severe thunderstorms/hail/lightning/high winds, and tornadoes are among the hazards that historically have had a significant impact.

Based upon the risk assessment, the MPC updated goals for reducing risk from hazards. The goals are listed below:

- Goal 1: Mitigate the effects of potential natural hazards in Laclede County to protect lives and assets.
  
- Goal 2: Reduce the potential impact of natural disasters to property, infrastructure, and the local economy through cost-effective and tangible mitigation projects whenever financially feasible.
  
- Goal 3: Encourage continuity of operations of government and emergency services in a disaster.
  
- Goal 4: Increase public awareness of natural hazards that have the potential to impact Laclede County.

To advance the identified goals, the MPC developed recommended mitigation actions, as summarized in the table on the following pages. The MPC developed an implementation plan for each action, which identifies priority level, background information, ideas for implementation, responsible agency, timeline, cost estimate, potential funding sources, and more. These additional details are provided in Chapter 4.
