EXECUTIVE SUMMARY

The purpose of hazard mitigation is to reduce or eliminate long-term risk to people and property from hazards. Randolph County and participating jurisdictions and school/special districts developed this multi-jurisdictional local hazard mitigation plan update to reduce future losses from hazard events to the County and its communities and school/special districts. The plan is an update of a plan that was approved in April 2015. The plan and the update were prepared pursuant to the requirements of the Disaster Mitigation Act of 2000 to result in eligibility for the Federal Emergency Management Agency (FEMA) Hazard Mitigation Assistance Grant Programs.

The Randolph County Multi-Hazard Mitigation Plan is a multi-jurisdictional plan that covers the following jurisdictions that participated in the planning process:

- Unincorporated Randolph County
- City of Moberly
- City of Clark
- City of Huntsville
- City of Higbee
- Village of Renick
- Village of Cairo
- Higbee R-VIII School District
- Moberly School District
- Westran R-I School District
- Renick R-V School District
- Moberly Special Road District

The Village of Jacksonville, City of Clifton Hill, NE Randolph County School District, Moberly Area Community College and Central Christian College was invited to participate in the planning process, but did not meet all of the established requirements for official participation. When the future five-year update is developed for this plan, the jurisdictions and school district will be invited again to participate.

Randolph County and the entities listed above developed a Multi-Jurisdictional Hazard Mitigation Plan that was approved by FEMA in April 2015 (hereafter referred to as the 2015 *Hazard Mitigation Plan*). This current planning effort serves to update that previously approved plan.

The plan update process followed a methodology in accordance with FEMA guidance, which began with the formation of a Mitigation Planning Committee (MPC) comprised of representatives from Randolph County and participating jurisdictions. The MPC updated the risk assessment that identified and profiled hazards that pose a risk to Randolph County and analyzed jurisdictional vulnerability to these hazards. The MPC also examined the capabilities in place to mitigate the hazard damages, with emphasis on changes that have occurred since the previously approved plan was adopted. The MPC determined the planning area is vulnerable to several hazards that are identified, profiled, and analyzed in this plan. Riverine and flash flooding, winter storms, severe thunderstorms/hail/lightning/high winds, and tornadoes are among the hazards that historically have had a significant impact.

Based upon the risk assessment, the MPC kept the goals from the previous plan for reducing risk from hazards. The goals are listed below:

<u>Goal 1 Public</u> Awareness- Using a variety of communications avenues to increase the citizens' awareness of and promote education about the natural hazards that they may face, their vulnerability to these hazards, and how to lessen the effect of future natural hazards.

<u>Goal 2</u> Strengthen communication and coordination between local governments, emergency personnel, public agencies, and citizens to mitigate the effects of future natural hazards.

<u>Goal 3</u> Investigate, implement, maintain, and enforce mitigation policies and programs that limit the impact of natural hazards: on the loss of life; on new and existing properties; on natural resources; on infrastructure; and on the local economy.

To advance the identified goals, the MPC developed recommended mitigation actions, as summarized in the table on the following pages. The MPC developed an implementation plan for each action, which identifies priority level, background information, ideas for implementation, responsible agency, timeline, cost estimate, potential funding sources, and more. These additional details are provided in Chapter 4.
