1. Call Meeting to Order

Chairman Glenn Eagan called the TAC meeting to order at 10:03 a.m.

2. <u>Determination of Quorum and Introductions</u>

Introductions were made to determine attendance. Quorum present.

3. Approval of the Agenda

Chairman Eagan asked for a motion to approve the agenda as presented. Motion was made by Alan Wyatt and seconded by Alan Winders. All members were in favor of the motion.

4. Approval of Previous Meeting Minutes

Chairman Glenn Eagan instructed the committee to look over the meeting minutes from the February 2022 TAC meeting. These minutes were provided for review prior to the meeting and an electronic version was displayed on the screen during the meeting. A motion was made by Wiley Hibbard to approve the minutes with amendments made to attendance list. Motion was seconded by Bill Allen. All members were in favor of the motion.

5. MoDOT Updates

Rob Frese provided the MoDOT update which included discussion regarding MoDOT's unfunded needs list and the newest STIP. The draft STIP was presented to the MoDOT Commission in May and posted on MoDOT's website for public comment. Once the comment period ends, the Commission will vote to approve the STIP at their July meeting. Rob also notified the group that construction on the Basinger Corner Roundabout will begin in late June. Lori Smith provided an update on the recent call for TAP projects with an application deadline of July 15, 2022. There was discussion regarding the changes to the BRO program, but no final details were available. The group will be notified as soon as more details become available.

6. 2022 Needs Prioritization Process Discussion

The needs submitted for the 2022 Mark Twain COG TAC Road and Bridge Needs Ranking were presented for each County. Voting for the ranking will be completed before the September TAC meeting.

7. Other Business

No other business was presented or discussed.
