Call Meeting to Order

Region B RHSOC Chairman Tom Yates called the meeting to order at approximately 9:37 a.m. and welcomed everyone.

OHS Grant Updates

Chelsey Call introduced the new Grant Specialist for the Regionalization program, Kristin Kayser. Chelsey also introduced Tom Hugh as the new Cybersecurity Specialist. Chelsey shared the FY 2021 Compliance Workshop was held the previous week and that completion of the National Cybersecurity Review is a requirement of all subrecipient again this grant year. She stated there was some confusion with NCSR competition certificates not being available this year, however, they have been added back in and will be required as proof by each subrecipient.

the RHSOC Chair or their designee, however, anyone is invited to participate. Devyn Campbell will put together a list of anyone that would like an invitation.

Devyn Campbell provided a list of past motions passed by Region B RHSOC regarding funding guidelines from May 2011 to present. Avis Marshall made a motion to remove the Region B restriction stating any requests for communication equipment must first be made to the Interoperable Communications Committee; motion seconded by Mike Kindle. Voice vote 13-Yes, 0-No. Motion carried.

After a lengthy discussion among the RHSOC, there were several recommendations made on how to address some of the scoring confusion for the future grant rounds, such as: Including Region B rules in the Notice of Funding Opportunity email (example- No Personnel), pre-meeting for applicants to answer any questions the RHSOC may have before the funding and voting meeting takes place, an additional set of questions set by Region B for applicants to answer during the application process, etc. This list is not all-encompassing and the conversation will continue at future meetings.
